

STARTRADE RO – Comisioane si taxe

Suma minima

Pentru a putea deschide un cont StartradeRO, suma minima ce trebuie depusa este de 500 EUR sau echivalentul in RON al acesteia. Aceasta suma va apartine si poate fi folosita pentru cumpararea de instrumente financiare.

Nota: Aceasta prevedere nu se aplica acelor clienti a caror activitate de tranzactionare se desfasoara prin intermediul altei institutii financiare (custode/depozitar).

Comisioane de tranzactionare

Comisionul de tranzactionare procentual pentru tranzactiile in lei se aplica la valoarea fiecarei tranzactii in parte (vanzare sau cumparare), avand o valoare minima de **1,9 lei/ordin executat** (integral sau partial). In cazul ordinelor executate prin mai multe tranzactii, comisionul minim este aplicat o singura data pe ordin.

STARTRADE RO – Fees and Commissions

Minimum amount

The minimum amount required to open a StartradeRO account is EUR 500 or its equivalent in RON, amount that belongs to you and can be used to buy securities.

Note: This provision does not apply to those clients whose trading activity is carried out through another financial institution (custodian / depository)

Commissions

The percentage trading commission for transactions in RON applies to the value of each transaction (buy/sell), with a minimum value of **1.9 RON / executed order** (full or partial). For orders executed through multiple transactions, the minimum commission is applied once per order.

- For transactions carried out on the **Regulated Market of the BSE**, as well as for transactions on the Multilateral Trading System of the BSE – **MTS** the commission is computed based on the following commission schedule:

When setting the trading commission, we will cumulate the average turnover over the last 3 months/ portfolio value of all the accounts on which the client is empowered.

1. Monthly Average Turnover Value over the past 3 months

Average turnover value over the past 3 months = [StartradeRO turnover (3 months) + StartradeINTL turnover (3 months)] / 3

2. Portfolio Value

Portfolio Value = [total value of the StartradeRO portfolio + total value of the StartradeINTL portfolio] at the end of the month for which the computation is made.

Note: For the first cash deposit/portfolio transfer from the Depository/ other brokerage house, the commission charged takes into account the value of the initial investment, which becomes Portfolio Value.

Bond Trading Commission

The commissions for transactions in RON with bonds and government securities is **0.2%** of the transaction value and **0.1%** of the transaction value for transactions with government bonds, with a **minimum of 1.9**

Comision intra-day

Reducere comision de ziua de nastere

S.S.I.F. Tradeville S.A. colecteaza aceasta taxa de la fiecare cumparator si o vireaza in contul A.S.F.

Cursuri de schimb / Taxe de transfer instrumente financiare/ bani/ modificari date personale

Cursul de schimb evidentiat de S.S.I.F. Tradeville S.A. pentru sumele depuse de clienti in conturile de tranzactionare StartradeRO este cursul practicat de banca/institutia de credit partenera a Tradeville, prin care se face operatiunea de schimb valutar.

S.S.I.F. Tradeville S.A. percepe numai taxele Depozitarului Central aplicabile in cazul operatiunilor de registru si de procesare evenimente corporative.

RON/executed order (full or partial). For orders executed through multiple transactions, the minimum commission is applied once per order.

For transactions carried out **in EUR, the minimum value** of the **trading commission is 1.9 EUR/executed order** (full or partial), the rest of the above clauses being applied accordingly, depending on the type of instrument traded.

Fees/withdrawal Revolut Commission

In case of supplies/withdrawals from/in Revolut, the bank fees and commissions are borne by the client. In case of foreign currency withdrawals in the clients' bank accounts, Tradeville will withhold from the client the fees and commissions charged by the bank.

ETF BET Tradeville Commission

For trades on ETF BET the commission is **0.25%** of the transaction value, **with a minimum of 1.9 RON/executed order** (full or partial). For orders executed through multiple transactions, the minimum commission is applied once per order.

Intra-day commission

Intra-day transactions carried out on the StartradeRO account (buy or sell of equal volumes of the same issuer's shares within one business day) will be charged at half of your standard commission, but no less than **0.25%**. The adjustment is made at the end of each business day. The intra-day commission does not apply on trades with bonds, government bonds and ETF BET.

Commission Birthday Discount

On the account's holder birthday, SSIF Tradeville S.A. offers a 20% commission discount on transactions made that day. If the date of birth is on a non-working day, the discount will be applied to the transactions made on the first trading day.

ASF fee charged for "buy" transactions

Pursuant to provisions of the recast FSA Regulation no. 16/2014 on the income of FSA, with following modifications, the brokerage houses that conduct transactions on the capital market have the obligation, based on daily trading reports issued by the Bucharest Stock Exchange to withhold from the buyer's account, a fee applied to the value of "buy" transactions.

Currently, for the purchase of financial instruments – shares, the FSA tax is 0.06%, for bonds is 0.02%, for ETFs the tax is 0.04%, for „rights” is 0.04%, for government bonds is 0%.

SSIF Tradeville S.A. collects this fee from each buyer and wires it into the account of the Romanian Financial Supervisory Authority.

Exchange rates / Share/Money Transfer and Personal Data Correction Fee

The exchange rate highlighted by SSIF Tradeville S.A. for the amounts deposited by clients in the trading accounts StartradeRO is the exchange rate practiced by the partner bank/credit institution of Tradeville, through which the foreign exchange operation is performed.

Tradeville withholds only the fees charged by the Central Depository applicable to registry and corporate events processing operations.

Dispozitii finale

SSIF Tradeville S.A. does not charge for RON deposits or wire transfers.

Fees charged by partner banks for transfers in currencies other than RON will be paid by the client.

Note: The responsibility as well as the execution of these operations rests with the custodian, in case the client's trading activity is carried out through another financial institution (custodian/depositary).

Tax on capital gains for natural persons

The tax liabilities related to the investment activity are established based on the Tax Code. In accordance with the legal provisions in force, individuals are required to determine annual net income / loss on the income statement and to submit it yearly to the competent tax.

SSIF Tradeville S.A will provide its clients with the necessary supporting documents in this regard, according to the law applicable at the time.

For companies there is no specific tax on capital gains. This goes into determining the taxable base.

Custody fee

The custody fee is 0.08% per year, calculated and paid monthly, starting the first calendar day of the month following that in which the INTL trading account was opened. The calculation basis for determining the custody fee is the value of the Client's portfolio of financial instruments on the last calendar day of the month for which the commission is due. No custody fee is due for the period during which the Client's account is subject to a seizure/garnishment order. The collection of the custody fee will be resumed starting with the day immediately following the lifting of the seizure / garnishment.

The custody fee will be automatically withheld by Tradeville, on the month following the one for which the fee is due, the client being obliged to ensure the appropriate cash available in the trading account, on each currency separately.

Fees for supplies/withdrawals through payment institutions/electronic money issuers

In case of supplies/withdrawals from/in accounts opened with payment institutions/electronic money issuers, the bank fees and commissions are borne by the client. In case of foreign currency withdrawals in the clients' bank accounts, Tradeville will withhold from the client the fees and commissions charged by the bank.

Exchange Rate/ Money Transfer Fees / Financial Instruments Transfer Fees:

SSIF Tradeville S.A. may perceive a fee of 0.08% of the amount deposited or withdrawn to/from the StartradeINTL trading account. For the amount deposited or withdrawn into / from the StartradeINTL trading account opened in EURO, the commission charged is 0%. Retaining the fee of 0.08% of the withdrawn amount from the client trading account is made by deducting it from the requested amount.

To convert the amounts of money deposited by clients in trading accounts on foreign markets, Tradeville uses the exchange rate displayed by its partner bank/ credit institution through which the conversion is carried out.

Tradeville withholds only the fees charged by the Foreign Intermediary applicable to registry and corporate events processing operations. Each adjustment made by the Foreign Intermediary to this fees and commissions results in the modification of the fees charged by SSIF Tradeville S.A., with their corresponding notification to the Client.
